

#### **Examples of expected achievements**

- Actions under the cross-cutting priority of knowledge transfer and innovation will focus on resource efficiency and the shift to a low-carbon and climate-resilient economy: around 11 000 people will receive training and 155 cooperation projects will be supported.
- The competitiveness of the agricultural and forestry sector will be improved through the support for investments in some 600 farms focusing on animal welfare, high-quality production and improved working conditions.
- To address the priorities of animal welfare and risk management in agriculture support will be provided respectively to 800 projects improving animal welfare and to 130 public bodies for coastal and flood protection.
- The key environmental challenges will be addressed through bringing 6.4 % of farmland under biodiversity contracts, 2 % under contracts for improving water management and another 0.5 % under contracts to reduce soil erosion.
- Emphasis under the resource efficiency and climate priority will be given through support to about 110 investment projects in energy efficiency and reduction of Greenhouse Gas (GHG) and ammonia emissions.
- Around 42 % of the rural population will benefit from local development strategies drawn by 40 Local Action Groups (LAGs) and another 18 % will benefit from improved services and infrastructure. Broadband coverage particularly will be improved for 16 % of the rural population.

### **Examples of key challenges**

- Addressing climate change and its effects is a major challenge in Lower Saxony and Bremen. Coastal regions are facing increasing
  flood hazard therefore flood protection measures and the development of internal and transitional water courses become a priority.
- Climate change is also causing problems of water and soil erosions, which together with the loss of biodiversity represents a key environmental challenges in the region.
- The depletion of rural areas' human capital and potential is also a major challenge. This is exacerbated by ageing society and population losses linked to migration of young people, especially women.
- Rural areas also face problem of connectivity since broadband internet connection is limited only to major towns and their vicinity
  while the coverage is limited to only 10 % of rural areas.





### 3. Planned expenditure per priority



Expenditure under Priority 4 is programmed for the priority as a whole, not for individual focus areas.
