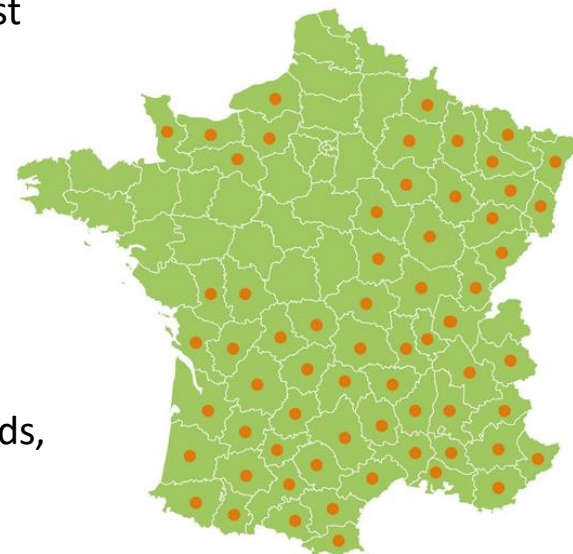


Part of the Collective Mobilization for Rural Development project of the National Rural Network

Specific forest issue, treated through concrete situations :

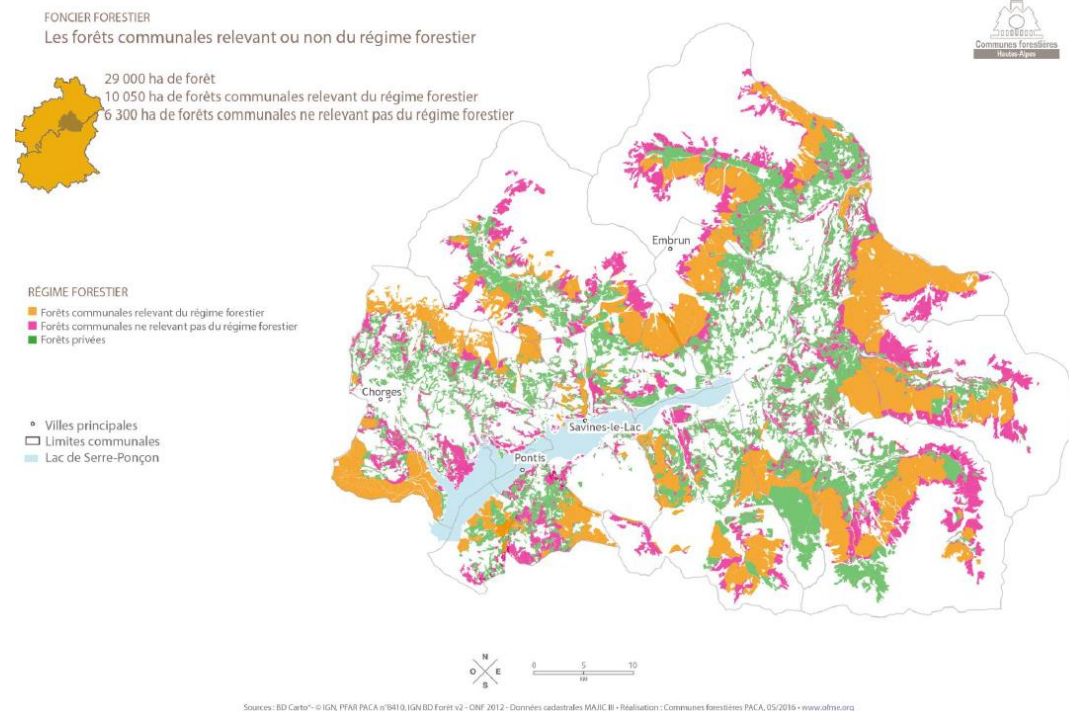
- European funds for forest & wood,
- Forest lands consolidation,
- Forestry & Pastoralism,
- Overabundance of game species & Regeneration of forest stands,
- Economic structuring of local sectors (timber, fuelwood...)



Local action and consultation in order to find the most suitable strategies for each issue.

Promotion of new models of collective territorial strategies

- More effective management of crisis situations (forest fires, bark beetles...)
- Massification of forest regeneration (adaptation) plans
- Mutualization of forest exploitation works

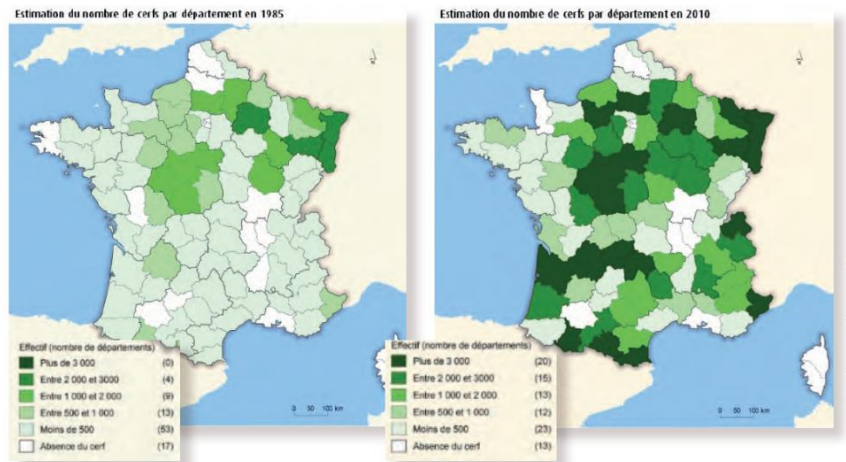


Restoration of the forest-game balance

Promotion of agro-sylvo-hunting dialogue to avoid the geographic transfer of imbalance



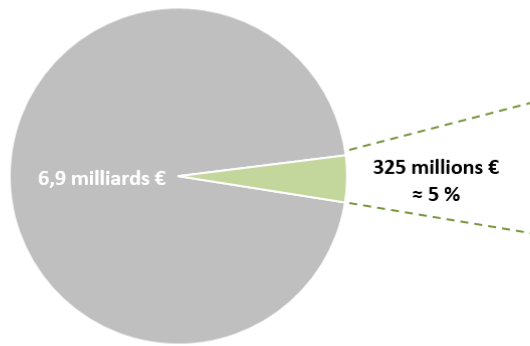
Climate change adaptation of forests : balance to be stabilized upstream of the replanting process

Rational use of stimulus funds, to maintain a balanced age structure of the forest resources to sustainably feed the wood industry

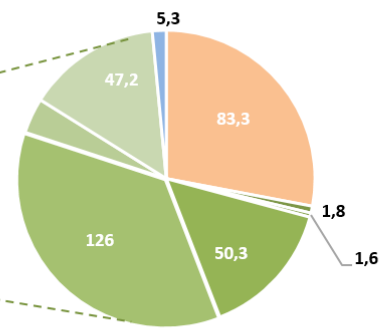




Montant engagé des mesures forestières et du FEADER² (mds €)



Montant engagé par sous-mesure forestière (M €)

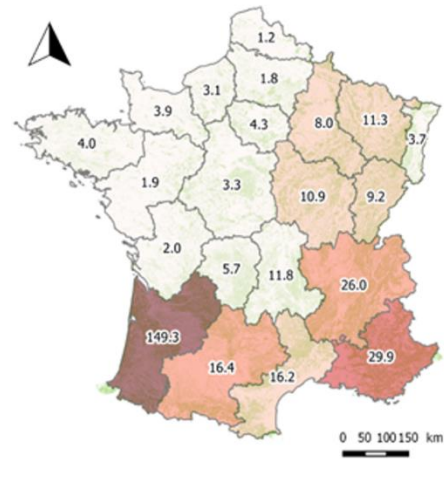
