The meeting will focus on effective approaches to support the transition to fully sustainable practices in agriculture and forestry, and analyse how the future CAP could best be used to upscale them. The programme will be built around experiences from the Rural Development Programmes, as well as other relevant initiatives such as the LIFE programme, Horizon 2020 projects, or national, regional or local initiatives.


The meeting will highlight, among others, approaches that deliver simultaneously on various Green Deal and CAP objectives on eg. biodiversity, water and soil management, climate resilience and economic and social sustainability. These experiences may be linked to disseminating practices such as agroforestry, sustainable forest management, preserving biodiversity on agricultural land, effective nutrient management, Integrated Pest Management, low input farming and management practices, integration of landscape features into the farmed environment, or practices contributing to climate change adaptation or mitigation through farming, livestock management, or forestry.

The attention will be on success factors of initiatives that have succeeded in upscaling and disseminating such practices, including through results-based payment schemes, advice, networking or collective and territorial initiatives.

Aims

- To identify the smartest ways to replicate or upscale effective approaches under the future CAP, including by combining pillar 1 and 2 interventions.
- To provide inputs to a factsheet on possible approaches to green interventions in the CAP Strategic Plans.
